

RHEEM & GALVIN'S PLUMBING SUPPLIES WIN A GARMIN FORERUNNER WATCH PROMOTION



TERMS AND CONDITIONS

- The Promoter is Roy Galvin & Co Pty Ltd trading as Galvin's Plumbing Supplies (ABN 85 008 719 408), of 3-5 Sundercombe Street, Osborne Park, WA 6017. Phone (08) 9441 8544.
- This Promotion commences for purchases made from 7.00am AWST on 02/10/2023 ("Start Date") and closes for purchase made at 5.00pm AWST on 01/12/2023 ("Promotional Period" and "Purchase Period"). Any purchase completed outside the Promotional Period and/or Purchase Period is invalid.
- 3. Information on how to enter and the prizes form part of these Terms and Conditions.

ELIGIBILITY

- 4. Entry into this promotion is only open to businesses and individuals who hold a Galvin's Plumbing Supplies account, and who:
 - a. in the case of businesses, are located in Western Australia and provide plumbing services in Western Australia; and
 - b. in the case of individuals, are registered plumbers holding a current valid plumber's licence issued in Western Australia, and are aged 18 years or older ("Eligible Entrants").
- 5. Where an Eligible Entrant is a business, if that entrant is drawn as the winner of the major prize, the relevant prize will be awarded to the nominated authorised representative for that business as recorded by Galvin's Plumbing Supplies, unless the authorised representative requests, and the Promoter agrees in its sole discretion, that the prize be awarded to another individual. Any individual nominated by the authorised representative to receive a prize must provide his or her consent to receipt of the prize.
- 6. - 9. For every four (4) Eligible Products purchased during the Purchase Period by an Eligible Entrant which is validly recorded against that entrant's Galvin's Plumbing Supplies Trading Account will generate one entry into the major draw.
- 10. As indicated above, multiple entries are permitted into the major draw, subject to the following:
 - a. Each Eligible Product must be purchased and recorded against the correct Galvin's Plumbing Supplies Trading account.
 - b. There is a limit of 1 major prize to be won per Eligible Entrant (i.e. an Eligible Entrant cannot win multiple major prizes)
 - c. One entry for every four Eligible Products purchased. For example, if an Eligible Entrant purchases 7 Eligible Products in the Purchase Period, they will receive one entry into the prize draw. VALIDATION

- 12. The Promoter may disqualify any person who is ineligible to enter this promotion, or any non-compliant entry (including an entry where an Eligible Entrant cannot provide proof of purchase of an Eligible Product), even if the Promoter only learns of that person's ineligibility or the entry's invalidity after the Promoter has awarded a prize to that person. In that case, the Promoter may require the person to return the prize or make a payment of the prize value to the Promoter.
- 13. - 38. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees:
 - a. The Promoter (including its respective officers, employees and agents) is not responsible, and excludes all liability whether in contract, tort (including negligence) or otherwise, for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of or in connection with:
